Committee welcomes and farewells

The Shared Care Committee welcomed Dr Baldev Sanghera as the new Family Practice Service Committee Representative.

The committee also shared a farewell to Dr Mitch Fagan and recognized his valuable work as the Family Practice Service Committee representative. Dr Fagan's appointment term limit with SCC concluded in December 2023.

Communities of Practice (CoP) Infographic

Laura Becotte, Senior Manager, JCC Learning and Development, provided updates on activities from the Chronic Disease, Child and Youth Mental Health and Substance Use (CYMHSU), and Perinatal Care Communities of Practice.

Notably, the CYMHSU CoP hosted its most successful <u>webinar</u> ever, in collaboration with UBC CPD, which garnered 1800 registrants.

JCC Indigenous Specific Anti-Racism and Cultural Safety Steering Committee

Tracy Elke, JCC Alignment Liaison, and Rachel Nolte-Laird, Senior Manager, JCC Aligned Strategic Initiatives, joined the meeting to request representation from an SCC physician member on the JCC Indigenous Specific Anti-Racism and Cultural Safety Steering Committee.

Dr Ian Schokking volunteered to be the SCC physician representative.

SCC Terms of Reference

Laura Anderson informed the committee on the progress of the SCC Terms of Reference (ToR) update following SCC's review and feedback on the document at the October meeting.

The SCC is collaborating with the JCC Alignment Team and the governance team to ensure that there is an accurate reflection of the PMA in the SCC Terms of Reference. Further, Laura will connect with JCC operational staff to understand what language can be used to refer to SCC members.

The ToR will be finalized once the new JCC Executive Vice President is hired, and the document will be returned to SCC for information.

SCC Expression of Interest (EOI) Intake and Review Process Update

Andrea McMaster, Liaison, Quality Impact, joined the meeting to provide a brief overview of the modified EOI intake and review process. The committee provided positive response on the improvements and emphasized the importance of incorporating a QI lens into projects to achieve sustainability and system impact.

Key Findings and Next Steps from Physician Services Committee (PSC) Priority Engagements

Brooke Knowlton presented a summary report detailing outcomes of engagements held by the Quality Impact team to understand how system partners plan to advance PSC's priorities.

The committee recommended connecting with ministries to identify leads for addictions and seniors' care. Additionally, the suggested inviting Liana Silver and Tanya Lorenz to present the PSC/JCC Workshop Impact Summary Report at the next meeting.
