Meeting Dates

Committee members provided feedback on the 2023 SCC meeting dates. Key changes proposed include:

- Committee meetings to be held on the third Tuesday of each month
- December SCC meetings to be removed
- May and September meetings to be held in person

The committee expressed concerns about conflicts with SSC meetings and the potential for large quantities of materials to review at once. They requested that JCC staff conduct an additional review of the meeting dates to ensure the most efficient approach is implemented.

Pain BC Demo Presentation

Gregg Moor, project manager at Pain BC, provided an update on the programs supported by Shared Care, including the BC ECHO for Chronic Pain, the Healthcare Provider Database, the BC Adaptive Mentorship Network for Pain, Mental Health and Substance Use, and Sustainability Planning.

Expression of Interest (EOI)/Proposal Process Finalization

Laura Anderson presented an update regarding the SCC Expression of Interest and proposal process finalization. To support streamlining and simplification, it was proposed that the current process is revised so that every community completes an EOI and a proposal form.

The committee approved the changes to the EOI and Proposal processes. Going forward, communities will complete both an EOI and a proposal form.

Digital Health Strategy and Connected Health System Update

Dawn Lake and Michael Tatto from the Provincial Health Services Authority presented an update alongside IT consultant Colin King on the Connected Health System, detailing the objectives of the Digital Health Strategy, Doctors of BC EMR survey findings, and the proposed approach to address current challenges.

Spreading Quality Improvement (SQI) Overview with Shared Care

Dr Lee Ann Martin updated members on the Spreading Quality Improvement initiative, highlighting key principles, core components of a successful project, and activities implemented to support effective learning and spread.
