PARTNERING WITH SHARED CARE

Community of Practice Infographic

Laura Becotte, Senior Manager, JCC Learning & Development, provided updates on the Chronic Disease, Child and Youth Mental Health and Substance Use, and Perinatal Communities of Practice (CoPs).

SCC Terms of Reference Update

Laura Anderson, Senior Manager, Quality Impact, provided an overview of the SCC Terms of Reference (ToR) and requested feedback and input from the committee to update and refresh the ToR to ensure they align with the 2022 Physician Master Agreement.

JCC Co-Chairs 2024–25 Workplan and Budget Update

Margaret English, Director, JCC Alignment, and Salimah Lalli, Manager, JCC Alignment, presented the workplan and budget. The workplan was approved by the JCC co-chairs at the September 12, 2023, meeting and is being circulated to each of the JCCs for endorsement. The Shared Care Committee approved the workplan and budget as drafted.

Strategic Planning

Adrian Leung, Director, Quality Impact, led a discussion to review the Shared Care networks in relation to the four strategic priorities requested by the Physician Services Committee (PSC) for the JCCs to focus on: surgery, cancer care, mental health and addiction, and senior care.

The committee agreed to align the function, purpose, and structure of the SCC networks, and to explore potential opportunities to leverage networks for improvement.

QI staff will contact the PSC secretariat for more information on the outcome of the PSC/JCC October 4 workshop and collaboration opportunities for future sessions.

Child and Youth Mental Health and Substance Use (CYMHSU) Community of Practice (CoP) Update

Dr Shirley Sze, CYMHSU CoP Steering Committee Co-Chair, provided updates on the activities of the Steering Committee and the Adverse Childhood Experiences (ACEs) Working Group.

Dr Sze provided updates on the CYMHSU 8th Annual Gathering, which took place on September 14, 2023, along with evaluation and participant feedback.

She also presented the 2023–25 Steering Committee strategic plan.

Connected Health System (CHS) Strategy Update

Dawn Lake, Director, Digital Health and Privacy Officer, Doctors of BC, and Darryl Tourond, Managing Partner, Provincial Health Services Authority, provided updates on the CHS strategy, including providing an overview of the SCC-funded physician engagement in CHS projects, and the Digital Referrals and Orders initiative.

The OceanMD platform was discussed, including its features, capabilities and benefits, and objectives on how the platform will improve patient, provider, and staff experience.

The CHS team recommended taking a proactive approach in engaging with existing projects and new requesters about the OceanMD platform, and providing education about how it can support their project.

The committee inquired about multilingual support, collaboration with PHSA, and opportunities for patients to complete patient report outcome measures.
