## **Committee welcomes and farewells**

The Shared Care Committee welcomed Dr Trudy Adam as the Shared Care Committee Specialist Representative Alternate.

The committee also shared a farewell to Carole Gillam and recognized her valuable work as Vancouver Coastal Health Authority Representative at Shared Care. Departing to a new role with PHSA, Candice Manahan, Northern Health Representative for Shared Care was also thanked for her many years of involvement.

# **Communities of Practice Update**

Laura Becotte, Senior Manager, JCC Learning & Development, provided updates on the Chronic Disease, Child and Youth Mental Health and Substance Use, and Perinatal Care communities of practice (CoPs).

# Physician Leadership Scholarship Program Recommendations and Update

Dr Curtis Smecher provided the Physician Leadership Scholarship Program (PLSP) updates on committee membership, work to date, PLSP strategic priorities, and the workplan timeline.

The committee offered guidance with an emphasis on preventing financial depletion and suggested further integration with other partner leadership programs to provide more opportunities for training.

### **Pain BC Partnership Presentation and Discussion**

Jamie Carballo, Initiative Liaison, Fraser Health Region; Helena Daudt, Director, Education, Pain BC; and Greg Moor, Project Manager, Pain BC, presented the Pain BC Strategic Partnership and funding request, with a focus on enhancing the well-being of all people living with pain through empowerment, care, education, and innovation.

The three streams of this work were outlined: BC ECHO for Chronic Pain, BC Adaptive Mentorship Network, and Divisions of Family Practice Education on Chronic Pain.

The committee recommended involving UBC CPD in this work to manage the logistics of educational sessions while the Pain BC team creates the content and manages expert participation.

They further suggested working with a rural CME program and emphasized the importance of alignment with health authority priorities.

The committee approved the three-year Shared Care and Pain BC Strategic Partnership proposal and funding request.

#### SCC 2024–25 Workplan and Budget

Laura Anderson led a discussion on the SCC 2024–25 Workplan and Budget, focusing on SCC's current funding status. The workplan required shifts, partnerships, and opportunities for alignment.

The committee was supportive of funding the JCC Workplan and Budget in full, on behalf of all the JCCs, on a one-time basis for the upcoming fiscal year, recognizing that other JCCs are facing tighter budget constraints.
