## PARTNERING WITH SHARED CARE

Each month the Shared Care Committee (SCC) reviews Expressions of Interest (EOIs) and Proposals submitted from communities/Divisions of Family Practice and specialists interested in engaging in Shared Care work. The following are details of approved funding for 'new and ongoing' projects from the meeting.

## **JCC Staffing Update**

Joanna Richards, Executive Vice President, Joint Clinical Committees, provided a staffing update to the committee following a review of the committees' staffing support structure.

## Physician Services Committee Annual Orientation Letter

Adrian Leung, Vice President, Shared Care Committee & Strategic Initiatives, highlighted key points from the PSC direction letters provided to SCC.

The committee suggested discussing how the communities of practice (CoP) can be leveraged to improve recruitment and retention of physicians in BC, among other suggestions.

## **Shared Care Semi-Annual Report**

Kirsten Smillie, Senior Manager, Quality Impact Performance Measurement and Evaluation; Eric Young, Senior Analyst, Quality Impact; and Gavin Winn, Analyst, Quality Impact, presented an overview of the second SCC Semi-Annual report, including objectives, comparison data to the previous report, and additional recommendations.

The committee suggested additional opportunities for data collection.

# Integrated Model for Health and Wellbeing in Burnaby

Jeff Malmgren, Managing Partner, Durable Solutions; Sherman Chan, PCN Co-Chair, MOSAIC; Georgia Bekiou, PCN Co-Chair, Burnaby Divisions of Family Practice; and Kimberly Barwich, Program Director, Burnaby Neighbourhood House, presented a community partnership model that holistically serves Burnaby. They also requested feedback from the committee on potential collaboration opportunities.

The presenters recounted how, by connecting the Burnaby community, family doctors, and Fraser Health, and through social prescription, this model inadvertently increased primary care capacity and reduced emergency department visits.

The committee suggested reviewing the Icelandic Prevention Model "Planet Youth" and requested that the presentation slides be shared.
