## PRESENTATIONS | UPDATES

### Doctors of BC Strategic Plan

Anthony Knight, CEO, Doctors of BC, presented the Doctors of BC 2024–29 strategic plan, focusing on transforming the health care system, supporting doctors to be influential leaders in driving positive transformational change, and improving patient care.

The committee endorsed supporting physicians and advancing Truth and Reconciliation across the profession. They also highlighted the importance of engaging PQI members in health care.

### Connected Health System

Dawn Lake, Director, Digital Health Strategy and Privacy, Doctors of BC, along with her Provincial Health Services Authority (PHSA) colleagues presented an overview of CHS's main workstreams and requested funding for 2024–25.

The committee approved the budget and requested that a robust evaluation strategy be developed and to integrate an ongoing pre- and post-evaluation and measurement framework into the system. They also asked for additional details about the next phase and the scaling-up strategy.

### Physician Quality Improvement (PQI) Alums Update

Holly Hovland, Liaison, Quality Improvement and Dr Jane Lea, PQI Physician Lead, provided information on the provincial PQI alums engagement initiative, including a high-level overview of

PQI Level 3 engagement throughout BC and the Quality Streams Framework.

They also noted that resources should be allocated to align with the PSC priorities and asked that information regarding the interface of the coaching stream of PQI work with Shared Care be presented in the future.

### Health and Justice Alliance Collaborative Initiatives Discussion

Dr Shirley Sze, co-chair, CYMHSU CoP Steering Committee; Jane Morley, Consultant, Access to Justice BC; Jennifer Scrubb, Consultant, Community of Practice; and Brooke Knowlton, Manager, Strategic Initiatives presented an updated funding request for the Health and Justice Alliance, following their initial presentation to the SCC in February 2024.

The committee approved the funding request, but suggested they pursue additional MoH funding to improve upon the initiatives. They also requested that a comprehensive communications plan be developed alongside the Doctors of BC Communications team and provided to the committee prior to promoting public education activity.

### Communities of Practice (CoP) Discussion

Laure Becotte, Senior Manager, JCC Learning and Development; was joined by Sonia Virk, Katie Purych, and Poppy Murray, Senior Project Coordinators, Community of Practice; and Brooke Knowlton, Manager, Strategic Initiatives. The group provided updates on CoP activities and to seek SCC's feedback on leveraging the CoPs moving forward.

The committee provided updates on outcomes from meetings with PHSA and BC Cancer representatives. They recognized the value of the structure of the CoPs and identified areas of interest and opportunity within each of the CoPs.
