PARTNERING WITH SHARED CARE

Each month the Shared Care Committee (SCC) reviews

interested in engaging in Shared Care work. The following are
details of approved funding for 'new and ongoing' projects
from the meeting.

Proposals

- PHSA Optimizing adoption of new clinical guidelines for the treatment of chronic kidney disease.
- North Shore Opioid replacement therapy in short-term custody.
- Nanaimo Primary care community disaster response plan project.
- Victoria Supportive cardiology tools SPREAD.
- Burnaby Sharing Care Collaborative developing pathways between health and social programs.

Cancer Review Panel Report

- Improving lung cancer diagnosis in the South Okanagan.
- Symptom management and quality of life support for patients with gynecological cancers after surgery and/or pelvic (chemo)radiotherapy.
- Equity model of cancer care for the Downtown East Side.
- Fine-tuning of a digital remote symptom monitoring program (RESPONSe) at Richmond Hospital to reduce acute care usage.

- SABR-ME Improving capacity to provide SABR (stereotactic ablative radiotherapy) for spinal metastasis across British Columbia through mentoring and education.
- Improving communication between radiologists and radiation oncologists for timely referral of urgent spinal cord compression cases.
- Supporting patients on endocrine therapy for breast cancer to reduce symptoms.
- Reduction of wait times for tissue diagnosis in incidentally detected cancer.
- Outpatient IV chemotherapy, an innovation to optimize health care service delivery in pediatric, adolescent and young adult oncology patients in BC.
- Increasing community oncology network capacity through alternative care pathways for low-risk oral therapies.
- Improving access to evidence-based group psychotherapy for BCCA patients.
- Rapid autopilot program (RAP) for expedited diagnosis of unsuspected lung cancer in Fraser region.

Physician Leadership Scholarship Program Recommendations and Update

Vivian Chan provided an update on the Physician Leadership Scholarship Program (PLSP) and requested a decision on the recommendations outlined.
