2026 Partners in Care Event Visioning

Ranjit Sekhon presented a briefing note (BN) to the committee regarding the venue, dates, and working group membership for the 2026 SCC Partners in Care Event. The committee was asked for feedback and a decision.

The committee approved the venue and dates for the 2026 event and appointed committee members to participate in a working group.

SCC Strategic Session Overview

Adrian Leung provided information for the strategic discussions, which comprised the remainder of the meeting agenda. Discussions focused on innovation, quality improvement, scalability, sustainability, and advancing network priorities.

Innovation and Quality Improvement

Laura Anderson discussed the development and implementation of Shared Care 2.0, emphasizing the importance of supporting physicians and project managers with training and resources. A summary of changes to the SCC project Expression of Interest (EOI) process, and an analysis of themes and lessons learned was provided, followed by a breakout discussion to explore the impact of the changes. A decision was requested to formally approve the delegation of the decision-making authority regarding EOI approvals to the Review Panel.

The committee had extensive feedback including the need for a reassessment following a full year of Shared Care 2.0, need to consult QI experts, highlighting challenges around duplication and knowledge sharing, among others.

The committee did not approve delegating the Expression of Interest decision-making authority to the Review Panel at this time. Laura Anderson will use the committee's feedback to develop a revised EOI process to enhance the review procedure and ensure EOIs can transition into sustainable proposals that effectively demonstrate system impact.

Dr Ian Schokking, Eugene Johnson, and Adrian Leung will discuss presenting a proposal for coordinating the spread and scaling of activities across the JCCs at the JCC Co-Chairs table.

Spread, Scale and Sustainability

Adrian Leung and Laura Anderson presented background information and an overview of the current state of the spread

of successful projects and initiatives. With this context, they asked for the committee's feedback on the future of Shared Care spread and sustainability.

Laura Anderson to connect with the Communications team to explore creating a focus group to improve The Exchange platform, with a focus on searchability and user-friendliness. Initial scoping to take place over the summer. Further, she will explore ways to create direct pathways to the proposal phase, bypassing the EOI phase, for projects that build on past projects with similar themes, aiming to promote spread and minimize duplication.

Advancing Network Priority Mapping and Toolkit Project

Brooke Knowlton introduced the consultant team, which supports identifying the current state of the SCC network ecosystem and producing a toolkit of guidance and best practices for the SCC.

The committee inquired about the project's progress and about networks within the larger health authorities and the need for communication with those.

Adrian Leung and Brooke Knowlton will coordinate with the consultant team to incorporate CoP learnings into the network mapping discussions, aiming to identify success factors and best practices for effective implementation resourcing.

Measurement and Evaluation

Ranjit Sekhon presented an overview of the JCC Impact Guide and conducted a breakout group activity to enhance the committee's knowledge of the new Quintuple Aim framework.

The committee noted that cultural safety and planetary health should also be considered and recognized within the context of the Quintuple Aim
