

## PARTNERING WITH SHARED CARE

Each month the Shared Care Committee (SCC) reviews Expressions of Interest (EOIs) and Proposals submitted from communities/Divisions of Family Practice and Specialists interested in engaging in Shared Care work. The following are details of approved funding for 'new and ongoing' projects from the meeting.

- Newcomer Women's Health – Burnaby
- Collaborative Model to Opioid Prescribing – Fraser Northwest
- Dawson Creek Imaging – Northern Health
- Value-Based Health Care – Providence Health

## PRESENTATIONS | UPDATES

### EOI/ Proposal Consultation

Laura Anderson presented a proposal for revisions to the EOI intake process for SCC. Proposed changes include:

- Harmonization of project intake processes
- New EOI form which focuses on broader initial scoping of the idea
- A communication and change management plan for revisions

The committee were generally in favour of the lower barrier to accessing EOI funding but requested that additional consultation with Specialists was undertaken prior to finalization.

### Centre of Excellence Update

Aman Hundal, Portfolio Liaison for Spreading Quality Improvement joined Adrian Leung to provide a phase two update on the Centre of Excellence:

- MoH and health authority reps joined the working group
- Looking at the core issues identified in proposals, and if this is truly addressed through the project
- Phase three will look at solutions and implementation

The committee shared positive feedback about the direction for the working group and requested that a PHSA representative be added to the group.

### RACE Update

Sarah Forster provided an update on the RACE App upgrades releasing in mid-July. Development costs were greater than expected and the maintenance contract is currently under renewal. The team has worked to strengthen the process for communication and work requests with the developer.

Committee members highlighted the need for more specialists to participate in RACE and suggested a broader conversation

among the JCCs to gather recommendations for long-term peer support services.

### Medication Management Update

Brooke Knowlton provided an update on the medication management initiative and presented a briefing note for decision.

Two options were presented to SCC for decision:

- **Option one:** form a task group to develop priorities and partnership opportunities
- **Option two:** Shared Care staff to develop priorities and an action plan based on engagement to date

The committee agreed with option one and noted the importance of considering unattached patients, pharmacists, relevant MoH connections, and Primary Care Networks in this work.

### Sunshine Coast Palliative Care Presentation

Dr Carmen Goojha, Kathy Copeman-Stewart, Tess Huntly, and Jackie Scott shared an update on the Sunshine Coast palliative care project. The project has yielded an increase in conversations and activities surrounding advanced care planning, both from patients and care providers and successfully collaborated with shíshálh Nation and other health system partners.

The "green sleeve initiative," which placed kits inside patient homes including patient documentation, has proved popular among patients and families. Going forward, the program will be considering the addition of other resources (e.g., legal or financial services), as requested by patients.

### ADHD Skills Project Update

Chrissy Tomori joined Dr Elisabeth Baerg Hall to present an update on their ADHD Group Medical Visit and Executive Function Skills Group (ADHA Skills) in post-secondary work. Despite the challenges of COVID-19, the team successfully pivoted to provide virtual support of their "Skills for Success: ADHD Strategies for Post-Secondary Students" program.

Next steps for the project include piloting and evaluating MSP-funded group medical visits within the community, developing partnerships with those providing or referring to this service, and developing linkages with current community referral structures to improve efficacy.

Committee members noted that unattached patients may be further underserved and discussed challenges with referring this patient population to ADHD skills treatment.
