

# **Meeting Summary**

**KEY HIGHLIGHTS OF SCC MEETING: JUNE 27, 2023** 

## PARTNERING WITH SHARED CARE

Each month the Shared Care Committee (SCC) reviews Expressions of Interest (EOIs) and Proposals submitted from communities/Divisions of Family Practice and Specialists interested in engaging in Shared Care work. The following are details of approved funding for 'new and ongoing' projects from the meeting.

- Kootenay Boundary Unattached Patients Care in a Time of Primary Care Crisis
- North Shore Enhancing Patient Flow

# PRESENTATIONS | UPDATES

**Direction from Physician Services Committee (PSC)** Adrian Leung, Director, highlighted key points from PSC direction letters to Shared Care and JCC.

An enhanced focus on evaluation was directed to all JCCs, with more details to be shared once the overall measurement structure for JCCs is developed.

Further exploration is required on how best to collaborate and support SSC on the four Health Priorities from PSC: addiction, cancer, seniors, and surgery.

The committee noted that it is important to understand the order of the priorities set out by PSC. Additionally, there was a discussion around Human Health Resources challenges.

#### Shared Care Input in Spread and Alumni Activities

Aman Hundal, Portfolio Liaison, delivered an overview of the "Spread and Alumni Process for Input" briefing note that was distributed to the committee.

He noted the goal is to work across SCC and SSC to discuss details on spreading successful Shared Care projects and leveraging PQI Alumni to address system priorities.

Two town halls are scheduled to discuss further details with key partners.

#### Shared Care Semi-Annual Report 2023

Kirsten Smillie, Senior Manager, presented an overview of the SCC Semi-Annual Report.

- 42 final reports were analyzed using the 0–3 rubric to assess the impact on each IHI Triple Aim component.
- Based on this analysis, three recommendations were made:
  - $\circ$   $\quad$  Revamp the proposal review process.

- Reconsider funding allocation and support.
- Enhance opportunities to collect and share learnings.

The committee discussed evaluation, measures, and data practices as part of this work.

## Provincial Health Services Authority (PHSA) and Shared Care

Dr Sean Virani, VP Medical and Academic Affairs, PHSA, provided an overview of medical affairs and collaborative work with other partners. Dr Michael McKenzie, MAiD Medical Director, PHSA, presented on the PHSA PQI Alumni Network.

The committee suggested avenues for further collaboration, including connecting with Communities of Practice and Ministry leads.

#### **Digital Health Strategy Status Update**

Dawn Lake, Director, Digital Health & Privacy Officer; Darryl Tourond, Project Director, Connected Health System Program; and Colin King, Managing Partner, PHSA, provided an update on the Digital Health Strategy.

The committee inquired about PQI involvement in DHS, change management, and communications planning.

## North Shore Division of Family Practice: ADHD Spread – Project Update

Drs Betty Tang, Dean Brown, and Elizabeth Baerg Hall, and Cynthia Bucket, ADHD Spread Project Lead, provided the project outcomes and next steps of provincial spread.

They detailed that the project has enabled primary care physicians to diagnose uncomplicated ADHD patients in only five to six short visits, reducing wait time, morbidity, and mortality.

The team connected with Dr Daisy Dulay from SQI to gain insights on expanding the project from local to provincial.

The committee noted the similarities between this initiative and CBT Skills and suggested creating an infrastructure for both projects to leverage one another.
