

KEY HIGHLIGHTS OF SCC MEETING: May 10, 2022

PARTNERING WITH SHARED CARE

Each month the Shared Care Committee (SCC) reviews Expressions of Interest (EOIs) and Proposals submitted from communities/Divisions of Family Practice and Specialists interested in engaging in Shared Care work. The following are details of approved funding for 'new and ongoing' projects from the meeting.

PRESENTATIONS | UPDATES

Physician Services Committee

Dr Jiwei Li and Adrian Leung summarized the feedback provided by the Physician Services Committee (PSC), including approval of the Shared Care Workplan. The Digital Health Strategy has been identified as a priority with a recommendation to engage providers to look at opportunities for investment in interoperability.

Strategic Brainstorming

- Led by Dr. Ian Schokking, Dr. Jiwei Li, and Adrian Leung, members engaged in an open conversation regarding opportunities to optimize the work of the SCC and advance the strategy. Committee feedback included:
 - 1. Clarification on differences between research questions and QI projects.
 - 2. Support to enable physicians to lead and shape projects, in which understanding the historical context is essential.
 - 3. Having metrics and information centralized.
- Actions: QI staff to discuss current processes and identify barriers and opportunities within Shared Care projects.
- Action: QI staff to determine how strategic change can be addressed on a systematic basis.

Emergency Preparedness Project Updates

Dr Graham Dodd, Rhonda Eden, Chelsea Brookes, and Tim Shoults presented an update on the Thompson Region: Emergency Preparedness project.

- Members highlighted the need to think about how we educate professionals throughout their careers in planning for an emergency.
- Intention is to have annual or bi-annual events to reach out to division members and prompt them to update emergency plans, if they haven't already.

SSC/SCC Leadership Scholarship Review Updates

Candice Manahan provided an update on the SSC/SCC Leadership Scholarship review, which sought to clarify the goal of the scholarship and set up guiding principles.

- The team recommends:
 - 1. Making adjustments to improve on processes and criteria of the Scholarship
 - 2. Host broader conversations on physician leadership
 - 3. Consider exploring more specific opportunities for group training
 - 4. Longer-term changes to be considered at a later date.
- Members suggested funding PQI alumni to provide QI coaching for physicians leading SCC projects or connecting with Ministry of Health/health authority leaders to understand and address system change opportunities.

Feedback on Meeting Format

- Members were invited to provide feedback on the first SCC Zoom/in person hybrid meeting.
- Members desire more clarity around attendance expectation for in-person meetings. The general consensus is aim to hold four meetings a year in person.
- JCC staff and IT team will explore sound issues for meeting rooms.

Feedback on SCC Snapshot Format

• Members expressed interest in a more easily-digestible format for the snapshot, potentially including line graphs rather than the current "traffic light" system.
